APPLICATIONS ARE DUE NO LATER THAN 3 WEEKS BEFORE THE TEST DATE. TEST SESSIONS ARE FILLED AS APPLICATIONS AND PAYMENT ARE RECEIVED. PSC MEMBERS RECEIVE PRIORITY UNTIL DEADLINE. FEES FOR TESTS CANCELLED BY THE SKATER LESS THAN 2 WEEKS PRIOR TO THE TEST FOR ANY REASON WILL BE FORFEITED. SKATER MUST SUBMIT A NEW APPLICATION AND PAYMENT TO BE RE-SCHEDULED.

*PSC Skaters submitting IJS results for test credit should send TEST CREDIT PACKET (protocol, results sheet, and test credit skater report) along with COACH STATEMENT and a \$20 processing fee to Patt Martin, 1563 Gamay Rd, Livermore, CA 94550. Allow 3 weeks for processing. Coach signature verifies that the athlete listed is eligible to receive Test Credit through the IJS protocol and they have seen the unaltered and correct scores, which match the protocol the athlete is submitting. Also that the coach understands that altering a protocol sheet to meet the test requirement is considered an ethics violation of US Figure Skating and The Professional Skaters Association.

All applicants must bring refreshments to test sessions for the judges. Refreshments are not required for tests held off of sessions.
